#### **Medicare Savings Programs**

Low-income older adults and adults with disabilities may qualify to receive financial assistance from the Medicare Savings Programs (MSPs). MSPs help millions of Americans access Medicare coverage at a reduced cost, yet only about half of eligible people in Minnesota are enrolled.

The MSPs cover Medicare premiums and may also cover Medicare out-of-pocket expenses for those who are eligible. MSPs offer relief from these Medicare costs, allowing people to spend that money on other necessities like food, housing, or transportation.

If your gross income is less than \$1,661 (assets less than \$10,000) as a single person, or gross income less than \$2,240 (assets less than \$18,000) as a couple, you may qualify. Call the Senior LinkAge Line at 800-333-2433 and a specialist can explain the programs, and help you get an application to apply.

#### **Expanded access to Part D Extra Help**

The Medicare Extra Help program helps low-to-modest income people pay for their prescription drugs. Currently, there are two tiers of Extra Help: partial and full. Beginning in 2024, everyone eligible for partial Extra Help will automatically become eligible for full Extra Help. This means that they will have greatly reduced Part D costs.

The Social Security Administration website (www.ssa.gov) has more information about the Extra Help program, including income and asset guidelines and how to apply. You can also call the **Senior LinkAge Line® at 800-333-2433** for help.

# Medicare Advantage Open Enrollment & General Enrollment Periods

The busy Medicare Annual Open Enrollment Period kicked off October 15th, 2023, and just concluded on December 7th.

Senior Senior LinkAge Line® staff assisted thousands of Minnesota Medicare beneficiaries with navigating, enrolling, or changing their Medicare Advantage and Medicare Part D plan options during this active period. The conclusion of the Annual Open Enrollment Period will usher in another enrollment period for 2024:

The Medicare Advantage open enrollment period starts on January 1st and continues through March 31st.

This period allows beneficiaries who are already enrolled in Medicare Advantage to:

- Switch to Original Medicare, a
   Medigap policy, and enroll in a Part D
   plan (Beneficiaries applying for
   Medigap/supplemental coverage might
   be subject to underwriting depending
   on circumstances).
- Switch to a different Medicare Advantage plan.
- Note: Only one plan change is allowed during this window.
