Adult Protective Services (APS) Community Supports

SEMAAA is partnering with the MN Department of Human Services and SE MN counties to provide short term case management and wraparound services to Adult Protective Services (APS) clients. The goal is to help stabilize APS clients and support their APS service plan. Utilizing American Rescue Plan Act funding, each client will have a budget that the SEMAAA case manager will use to purchase needed supplies and/or implement services.

Minnesota Department of Human Services 2024 Live Well at Home RFP Open

Due Date: Friday, April 5th 2024, 4:00 pm Central Time

Through the Live Well at Home Grant request for proposal (RFP), the Minnesota Department of Human Services (DHS) is seeking proposals to develop and/or provide services for older Minnesotans to live in the community of their choice by improving their community's capacity to develop home and community-based services.

- The term of any resulting contract is anticipated to be 12 month, from July 1st, 2024, until June 30th, 2025, with the option to potentially extend beyond that date. The maximum initial award per year is \$350,000.
- There is a dollar-for-dollar or 50 percent project total matching requirement for all grant funds expended.
- Completed proposals are due in the DHS online application portal by 4:00 pm CT on Friday, April 5th, 2024.
- The complete RFP, directions, and online application are available on the DHS Live Well at Home Grants website.
- Responders can strengthen their applications by connecting one or more of the Long-Term Services and Supports to one or more of the interconnected age-friendly domains of community living identified by the World Health Organization, AARP, and the Age Friendly MN Council listed in the Request for Proposal.

CULTIVATING FRIENDSHIPS THROUGH DEMENTIA AWARENESS GOODHUE MIDDLE SCHOOL AND GOODHUE LIVING

As a Dementia Friends Champion, I've been asked, "Why do you talk to students about dementia?" My initial response is "Because they know people living with dementia or have heard something about dementia." And it brings young students, from middle school through high school, together with families living with dementia and everyone benefits from the interaction. Here's an example.


In early 2023, the Goodhue FCCLA (Family, Career, and Community Leaders of America) and Leos (young Lions) students helped create over 160 Dementia Friends. Through a series of activities, they learned how to communicate with people living with dementia and how to help their care partners. They also were asked to consider an action they might take in their community to help families living with dementia.

In the summer of 2023, the FCCLA/Leos students chose a service project based on a conversation with a resident at Goodhue Living. Using funds provided by SEMAAA and the Goodhue Lions, they purchased two cedar raised garden beds, soil, and plants to install and plant at Goodhue Living. Four students worked with residents to set up, fill, and plant garden vegetables and flowers. Everyone enjoyed the day! The students were surprised by how much they learned from the residents about the best way to place the plants and seeds and how to water them without displacing the seeds.

Their FCCLA/Leos advisor, Carolyn O'Reilly, said the students learned how to initiate a project and allow people to work at their own pace. It was hard to not do something for the residents, but they remembered it was important to be patient with older adults and people living with dementia.

Two of the students, Francis and Patrick, decided to register the raised garden bed project at the regional FCCLA MidWinter meeting as a STAR event. As a "Chapter Service Project Display", they need to present a service project based on a concern identified by the students in their community. STAR events are judged at the regional, state, and national levels based on specific presentation guidelines. And Francis and Patrick are headed to the State FCCLA Conference in April!
